## HERE ARE THE 2021 EVENT PLANS

## WHAT GOT US THROUGH THE YEAR

Last week the Wall Street Journal featured the topic in the headline. They gave several examples of activities that helped people focus on something other than 'Sheltering In Place'. They included a school teacher that found fulfillment by buying a 2place airplane kit; a partially built Zenith STOL CH750 airplane. It turned out to be a ambitious project, but he found new airplane enthusiastic friends that have helped him make progress. He expects to finish it by summer and enroll in flight school.



Others have found satisfaction by building Lego models of famous buildings and exotic sports cars. (See photo above)

Some have taken up to run long distance marathons where distance between runners is greater than shorter runs.

Still others found getting dressed to go out - with no place to go - provided fun for others by posting photos of their elegant clothing on Facebook.

NCKCC 's own Gary O'Connor is our notable example in this vein. Many of you know about Gary's Corvair powered Woodster, that has graced our shows and has a history of extensive travel around the USA.

Well, Gary has a new project taking shape and he shared some pictures of it in the early stages.



Gary says, "I'm happiest when I'm working on something, especially something creative, and this COVID shut down allows me to be creative to my heart's delight. I have started another Woodie Roadster, this one based on a '32 Ford frame I bought several years ago for another project."

"I have been using CAD (cardboard assisted design) to visualize the shape, emulating a mid 30's, boat tail race car I cut out the shape for an American six cylinder engine, T-5 transmission and 19" wire wheels and tires. The body will be redwood strips again, but this time, rather than be thin strips glued onto flat sheet, the strips will be thicker, forming compound curves like a cedar canoe.



"I'm at the beginning of this project, hoping to have it done in a year or so. I've learned a lot about wood, fabrication and design over the last 50 years and I want to make this one the best of my builds.

I made a base for the body using layers of 1/8" plywood bent and glued to copy the shape of the frame. It ended up being 1-1/4" thick and held it's shape nicely. All of the body ribs will be mounted to this piece and it will be integrated into the finished body.

I recently spent some time giving my new car a 3D reality to see what it would look like and try it on for size. (See photo p. 4.) The biggest thing about a project is the time spent thinking about suspension, fuel tanks, engine placement, what will fit where, etc. Much of the chassis will just be a replay of what is under my truck (disc brakes, R&P steering, power dual master cylinder, coil over shocks) since it has all worked so well. I'm trying to find 18-19" wire wheels that will fit disc brakes.... been quite a challenge.

I have a friend in Brazil who will take my rough dimensions and smooth them into a 3D form and



then 'slice' it to give me the shape for all of the ribs to cut from 1/2" marine plywood. Then I'll cut and machine the cedar strips and glue them together 'canoe' style.

Some of the more recent pics don't look much different but I locked the frame into position and fabricated the body mounts. Most of those cross tubes were just for shaping the base. The body mounts are the 1" square tubing and will be welded to the frame. There are about 20 Nutserts holding everything together. I'm still looking for an engine and transmission but may have found an engine in Orinda. Chasing parts is half the fun though, isn't it?"

### SAVE OUR RACE CARS – EPA FACES COURT ACTION FROM SEMA

Following years of frustration felt throughout the automotive community, the U.S. Environmental Protection Agency (EPA) continues to deny the very foundation of motorsports. According to the EPA, current law (Clean Air Act – aka CAA) does not allow street vehicles—cars, trucks, and motorcycles—to be converted into race cars.

A recent lawsuit between the EPA and an aftermarket manufacturer is the agency's latest action against racing. In the lawsuit, the EPA again maintains that once a vehicle has been certified as a street vehicle, it cannot be converted into a racing vehicle even if that vehicle is trailered to the track and is never driven on public roads.

The EPA's position left the SEMA Action Network (SAN) with no choice but to strike back. The SAN filed a brief in court arguing that the Clean Air Act does not apply to certified vehicles used exclusively on the track.

As racers and fans know well, members of Congress introduced SAN-sponsored legislation to confirm what had already been understood for the previous 45 years: that the CAA did not apply to vehicles modified for racing use only. Hundreds of thousands of enthusiasts have since contacted Congress urging passage of the "Recognizing the Protection of Motorsports Act" (RPM Act). Enactment of this important critical bill into law would remove any doubt that it is legal to modify a motor vehicle for exclusive use on the track. It also would confirm that it is legal to produce, market and install racing equipment. The SAN continues to work tirelessly to pass this important legislation to counter EPA overreach.
