BLACK DIAMOND MINE TOUR -SATURDAY 3/12/16

This is a new event, located a bit south of Pittsburg, CA on Somersville Road, that we have never done before. It seems a good hedge for unpredictable March weather and that we expect to be mostly in the Visitors Center or the mine. The road to the Hazel-Atlas Mine reportedly is gravel and probably not friendly to show cars, so beware.

Hazel-Atlas Mine Tour

Tour participants can take a 950-foot walk into the mine to see mine workings, ore chutes, the shifter's office (mine boss), and ancient geological features. Because of its size and the need for safety, visitors will be taken in only on guided tours.

The tour is a 1.5 hour-long, advance-reservation tour that is offered at 11 a.m. on weekends March through November for groups of 10 or more by advance-reservation and credit card payment only. There is also a 12-noon tour that is available on a first-come-first-serve basis, but you need to be there 1-hour early to pay and participate. The tour costs \$5 per person and parking is \$5/car.

Meanwhile here is some background information.

Coal Mining

From the 1860s through the turn of the last century, five coal mining towns thrived in the Black Diamond area: Nortonville, Somersville, Stewartville, West Hartley and Judsonville. As the location of California's largest coal mining operation, nearly four million tons of coal ("black diamonds") were removed from the earth. The residents of the mining towns were from all over the world, and their life was characterized by hard work and long hours. Occasional celebrations and a variety of organizations and social activities served to alleviate the drudgery of daily existence.

The coal mines had a significant impact on California's economy. By the time operations ceased due to rising production costs and the exploitation of new energy sources, much of California's economy had been transformed from a rural to an industrial base.

Sand Mining

In the 1920s underground mining for sand began near the deserted Nortonville and Somersville townsites. The Somersville mine supplied sand used in glass making by the Hazel-Atlas Glass Company in Oakland, while the Nortonville mine supplied the Columbia Steel Works with foundry (casting) sand. Competition from Belgian glass and the closing of the steel foundry ended the sand mining by 1949. Altogether, more than 1.8 million tons of sand had been mined.

THE FINANCIAL STATE OF THE CLUB REPORT

NEW LAW ENABLES SALES OF TURN-KEY REPLICA CARS

Thanks to a new SAN-supported federal law, enthusiasts who want to own a replica car will soon have the option of purchasing a completed turn-key vehicle from the manufacturer. Hobbyists who want to install an engine in a kit car or build their own specialty constructed vehicle are still permitted to do so.

• Beginning in 2017, low volume manufacturers (up to 5,000 motor vehicles a year global production) will have the option of selling up to 325 completed replica vehicles in the U.S. each year.

• A replica is a vehicle that resembles the body of another motor vehicle produced at least 25 years ago (ex: '32 Roadster, '65 Cobra, etc.).

• Previously, companies were unable to sell turnkey cars since the National Highway Traffic Safety Administration (NHTSA) regulated these vehicles as if they were current model year vehicles, not vintage cars.

• The new law treats these replicas the same as kit cars, subject to certain equipment standards (lighting, tires, windshields, brake hoses, etc.),recalls and remedies but not vehicle standards

(roof crush, side impact, etc.).

• Replica vehicles produced by the companies will have a current model year engine package certified by the EPA or California Air Resources Board and are exempt from emissions testing. (Hobbyist kit builders still have the option of installing engines of their choice.)

• For information on how your home state regulates kit cars and replicas, please visit the SAN's "Tag & Title Toolbox."

• NHTSA and the EPA have one year to issue regulations to implement the new program. The SAN will work with these agencies to speed the process. Thank you to all who participated in supporting this bill.
