

- Saturday August 15, 2020 The Kensington Senior Living place is just a block off I-680 on Geary Rd. in Walnut Creek. It's a small show, and typically provides a picnic lunch for car owners.
- Sunday September 27, 2020 How does this sound for our NCKCC Annual Show at Blackhawk Museum in Danville. I haven't reserved the date yet so give us some feedback. Late in September the heat is less likely than earlier.

<u>SEMA SUES D.O.T. –NHTSA</u> <u>PROPOSES REPLICA CAR REGS</u>

Last month we reported on SEMA's lawsuit citing NHTSA for failing to produce regulations that were intended to allow low-volume automaker to make and sell up to 325 replica cars each year that resemble production vehicles manufactured 25 or more years ago.

Just after the January Newsletter was printed, I learned that a set of regulations had been written and were available for comment for 30-days. I thought it would be nice to find a review of the proposed regulations that could be summarized for your enlightenment.

I had no luck while searching the internet and I haven't seen anything from SEMA. What I did find is a 118-page proposal that can be reviewed at the following URL: <u>https://www.nhtsa.gov/sites/</u> <u>nhtsa.dot.gov/files/documents/</u> <u>replica_vehicle_program_nprm_12172019.pdf</u>

I copied the "Executive Summary" shown below and you will see several sections that will be difficult to be settled to everyone's satisfaction. Examples:

1.) VIN label rules may make it impossible for vehicles built in two or more stages to comply with VIN rules. Think of Superformance Cobras from South Africa.

2.) Requirements to resemble replicated vehicle may severely limit desirable deviations in wheelbase, width or length, relative to the replicated vehicle.

3.) Requirements to be licensed by the original manufacturer, to produce a replica. Do you think Ferrari will cooperate.

Just look at the sections and sub-sections and I think it will be a long time before these regulations will be settled.

Here is one of his ten favorites for 2019.

1957 Corvette - owned by a retired head of GM's Design Department, Ed Welburn.
Welburn was the sixth man to run the GM Design Department and first to lead GM's design globally.
He was keen on cars of the 50's though he thought 1957 was the "Golden Year", at least at GM.



His favorite predecessor was Harley Earl, who gained fame from the 1938 Buick Y-Job, shown below. Earl designed the LeSabre, another concept



car in 1951, the first Corvette came in 1952. He also introduced tailfins on 1948 Cadillacs.

Welburn bought his '57 Corvette from NY Yankee slugger Reggie Jackson and is looking forward to a 2020 Mid-engine Corvette with colors to match his '57.
