PLANNING 2020 CLUB EVENTS

Here's what we have so far:

 (A) Visit to Walt Disney Museum at the Presidio in San Francisco. They are open 10 am to 4:45 pm daily (except Tuesdays) Admission \$25 Adult, \$20 Senior, \$15 Youth 6-17 and possible reduced rates for groups of 10. Go to <u>https://waltdisney.org</u> for more info.

- (B) California Auto Museum, Sacramento will finish their British Car Display on January 27th and a new exhibit featuring movie cars is probable. But we could still plan on it if you show interest. This could be an event for April or May.
- (C) Wayne Wenger has a full length movie on the life of Madman Muntz. We gave you some info about him in the Dec '19 newsletter, but go to <u>www.madmanmuntzmovie.com</u> for more info. Wayne has offered to host the club at his home in Placerville, but the distance makes it a pretty full day. I have contacted Blackhawk Museum to see if they would consider it for a showing, but no decision yet.
- (D) A visit to Rosie the Riveter Museum in Richmond is another candidate. This is a National Park site and is pretty interesting. Try <u>www.nps.gov</u> for details. There is a restaurant, "Assemble Restaurant" right nest to the Visitor Center, which would make a nice way to start of finish a visit.
- (E) The Cobra Experience, in Martinez, is another possible place to visit. They have a free "Cars & Coffee" meet on the 3rd Sunday of each month, 8:30 to 10:30. They have a large Cobra Show scheduled for 6/6/2020 that is free to spectators.
- (F) The Kensington Senior Living place is just a block off I-680 on Geary Rd. in Walnut Creek. It's a small show, scheduled for 8/15/2020, and typically provides a picnic lunch for car owners.
- (G) A repeat of our 2010 visit to Castello di Amorosa Winery with a lunch at a nearby Calistoga restaurant might be timely. How many of you recall the 2010 visit?
- (H) Another repeat of our 2015 visit to the Western Railway Museum, on Hwy 12 in Suisun, CA, has been suggested. Some interesting electric railway history is available and a ride on an electric railcar is included with admission.
- (J) A new suggestion is a Bay Cruise on the USS Potomac. Cruises in 2020 are scheduled for Mother's Day and Father's Day and run \$85 to \$100 including a lunch. Docent-led dockside tours are also available and cost about \$8 to \$10.

2019 REPORT - STATE OF THE CLUB FINANCIALLY

The year 2019 was reasonably good for our club. Our expenses were slightly higher than our receipts so we ended with reduction in assets of \$181.78 This compares to a deficit of \$15.79 in 2018.

Our dues of \$695.92 more than covered the expenses of the newsletter printing and mailing (\$292.37) plus the costs of our website (\$194.39).

The challenges for the future include trying to add to our membership rolls, currently at 29 paid-up members. We have 1 new member in 2020 but the 2020 dues have barely started. Other challenges that I see that weigh on our hobby are the emphasis on electric powered vehicles and increasing fees that apply to our cars and the cost of compliance. We try to stay tuned to the ACCC to spot legislation, about which we can express ourselves by contact with our legislators.

SEMA SUES U.S. DEPARTMENT OF TRANSPORTATION FOR FAILING TO IMPLEMENT REPLICA CAR LAW

The Specialty Equipment Market Association (SEMA) filed a petition in federal appellate court to require the government to allow replica car manufacturers to immediately begin production of brand-new, turn-key vehicles.

Under a 2015 law—the Fixing America's Surface Transportation Act (FAST Act)—low volume automakers may sell up to 325 replica cars each year that resemble production vehicles manufactured at least 25 years ago. The FAST Act set a deadline of December 4, 2016 for the U.S. Department of Transportation's National Highway Traffic Safety Administration (NHTSA) to issue any necessary regulations to implement the law. The agency has yet to take any action.

Prior to enactment of the FAST Act, the U.S. had just one system for regulating automobiles, which was established in the 1960s and designed for companies that mass-produce millions of vehicles. The lack of regulatory flexibility prevented small businesses from manufacturing turn-key vehicles. Eager to produce replica vehicles under the new law, many companies made capital investments and took customer orders on the assumption that sales could begin in late 2016.

However, NHTSA has failed to issue regulations or undertake any other action allowing the small automakers to produce and sell vehicles as permitted by law.

"SEMA warned NHTSA in 2018 that it would file suit if companies could not begin production of turn-key cars as authorized by the FAST Act," said SEMA President and CEO Christopher J. Kersting. "SEMA has made every effort to work collaboratively with NHTSA for over three and a half years, although the agency has taken no action to implement the replica car law. Consequently, companies have not hired workers, businesses have lost money, and consumers have been denied their rights to purchase replica cars."

Vehicles produced under the FAST Act will be current model year clean cars. The U.S. Environmental Protection Agency and the California Air Resources Board have developed guidelines and regulations to confirm that the engine packages to be installed will meet current emissions standards.

The replica car provision was designed to be easy for NHTSA to implement, as it is an extension of the common-sense approach to overseeing kit car production that the agency has employed for decades. While the FAST Act requires NHTSA to "issue such regulations as may be necessary" to implement the law, the agency also has other options such as issuing a guidance document that will allow production to begin immediately. SEMA has asked the court to compel NHTSA to take action.

NORTH CAROLINA TO FURTHER EXEMPT OLDER VEHICLES FROM EMISSIONS TESTING

Time to celebrate, North Carolina! Beginning December 1, 2019, all motor vehicles 20 years old or older will be exempt from emissions testing. On that date, the applicable clause from a 2017 regulatory reform bill goes into effect. Currently, 22 of the state's 100 counties require vehicles model year 1996 or later to undergo an annual emissions inspection. The current emissions inspection exemption in these counties for new cars from the three most recent model years will also remain in effect . The new law, effective December 1st, acknowledges

the relatively minimal environmental impact of the older vehicles targeted for this exemption.
