## **FATHER'S DAY CAR SHOW AT BLACKHAWK MUSEUM**

On June 21st the Blackhawk Auto Museum again hosted a Father's Day car show.

I attended the show but was late, arriving about noon, and found a much smaller show than past years. The lower parking lot closest to the museum had a good variety of cars, several of which were displayed last year. Some of my favorites included 2 pedigreed '37 Cords and a nice Auburn Boat-tail Speedster that I would guess was a '34.





An unusual 3-wheeler that I haven't seen before was a Polaris Slingshot. It was a front engine, rear drive (single wheel) vehicle that the owner told me was a real 'autocross' contender. It was powered by a 2.4 liter, 4-cylinder GM Ecotec engine that claimed about 173 HP output. There were lots of late model cars including Corvettes and Porsches and a fair number of Macho 4-WD off-road machines plus the custom shown below.



The upper Plaza display had only 5 cars which included the 2 Cords mentioned above. The others included a Lotus Elite Turbo and an Indy-car racer. The most dramatic Plaza entry was a '37 Lincoln Zephyr that was extensively customized and 'drop dead' beautiful as you may have noticed on the cover.



## **RODS TO RAILS CAR SHOW - JAMESTOWN, CA - JULY 25th**

This is a new show for our club to attend, however Dave DeCato vouches for it as a "Good Show". The show runs from 7a.m. to 3 p.m. with awards presented at 2 p.m. The cost is \$35 including a \$10 Merchant credit. Dave tells me any car registered as 'Modified' will be parked on Main Street and 'Stock' car will be parked at Railtown Park. Keep that in mind when you fill out your registration form, which is available at [www.nckcc.com](http://www.nckcc.com) - click on Hotline.

Jamestown is an interesting town in the Gold Country with a population of about 3,400 and is located about 2.5 hours drive from Oakland on Highway 108.

A walk down Main Street in Historic Jamestown is a step back in time. You'll see a mixture of buildings from different eras. Wooden buildings dating from the winding down of the Gold Rush. Stone buildings with iron shutters from about the same time designed to withstand the fires that were common at that time. Wooden buildings in the Victorian style from the turn into the 20th century.

In the early summer of 1848—a few months after the famous discovery of gold at Sutter's Mill near Sacramento that started the Gold Rush—an Oregon man named Benjamin Wood discovered the first gold in the area in what is now known as Woods Creek. The discovery site is about 1 mile west of what is today downtown Jamestown.

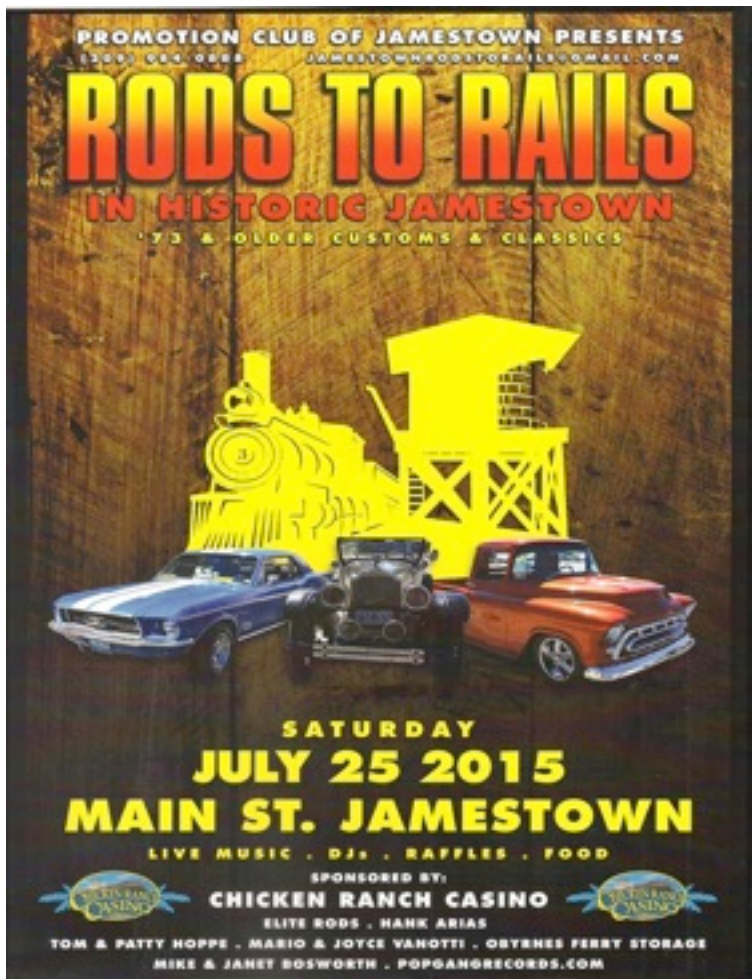
Jamestown was named for a man who came here from San Francisco named Col. George F. James, who set up a tent near Woods Creek selling food and supplies for the miners. He was the town's first *alcade*, a sort of Godfather-like official unique to the legal system at that time, when California was still part of Mexico. He eventually disappeared under a cloud, leaving many unhappy investors in his schemes.

Jamestown went through many boom and bust periods, and became more prominent at the turn into the twentieth century as a result of nearby underground quartz gold mines and the Sierra Railway, which transported quartz ore (with its embedded gold) to the plants in the Bay Area that extracted gold from it. The railway also shipped out lumber from the high country.

However, the Sierra Railway itself, unlike the vast majority of other short railway lines, survived, and it continues today, mainly hauling (with diesel

locomotives) lumber and lumber products from mills in Standard and Chinese Camp to Oakdale. Jamestown itself has also survived. It was the area's Red Light District until the 1950s, when Governor Pat Brown, then Attorney General, shut that form of entrepreneurship down. Jamestown's economy today is mainly tourism.

## **BILL COULD LAUNCH NEW AMERICAN CLASSIC CAR INDUSTRY!**

There could be more classic cars hitting the road soon. Cars that look like classics, that is. The Low Volume Motor Vehicle Manufacturers Act of 2015, introduced this month in the House of Representatives, would allow small companies to produce and sell ready-to-drive replicas of classic cars without subjecting them to the prohibitively expensive safety and emissions tests the major automakers' vehicles must undergo. Hobbyists build hundreds of Shelby Cobra, Ford "Deuce Coupes" and other vintage clones each year. State-by-state laws today allow the sale of component "kits" which must be assembled by the buyer or a third-party

shop. Under the new rules, registered companies would be allowed to produce and sell up to 500 finished cars in the U.S. each year that would carry a federally issued Vehicle Identification Number.

The bill, H.R. 2675, co-sponsored by Reps. Mark Mullin (R-Okla.) and Gene Green (D-Texas), is supported by the Specialty Equipment Market Association (SEMA), which represents the kit car and aftermarket parts industry. It would require these cars to use modern engines that have already been certified by their suppliers to meet current emissions standards, but it would exempt them from the most stringent federal safety regulations. Perhaps most importantly, the cars will have to be exact visual replicas of vehicles that are at least 25 years old, and their original manufacturers must license the designs. Stuart Gosswein, SEMA's senior director of federal government affairs, said previous attempts to create this type of low volume classification were stymied in part by opposition from some major automakers. Allowing only classic, and not unique, designs should make it more palatable for the industry to accept, he said. A spokesman for The Alliance for Automobile Manufacturers said the group was reviewing the legislation and had no comment at this time.

"The current law does not take into account the unique challenges that small auto manufacturers face when it comes to recreating historic cars," Mullin said in a press release accompanying the bill's introduction. "We can't expect these companies to be able to comply with a law that was established in the 1960s for automakers that mass-produce millions of vehicles every year. We need to encourage growth in our manufacturing market, not create unnecessary barriers." Gosswein predicts the impact on the auto industry will be small; eventually accounting for only about 1,500 cars a year, but even that number could create hundreds or thousands of jobs nationwide. Lance Stander, whose company, Superperformance, sells Shelby Cobra, Ford GT40 and Chevrolet Corvette replicas without drivetrains, expects his business will expand within a year from 20 to 100 people if the bill passes, and that it will make it easier to export its California-assembled products. He said a business like his would have to invest over \$100 million under the current regulations to become a fully-fledged manufacturer, even at the low volumes being targeted. He said he's excited by the prospect of potentially dozens of companies building new cars, likening it to the pre-World War II automotive industry before it consolidated into the Big Three.

David Smith, owner of Massachusetts-based Factory Five Racing, the largest manufacturer of kits, said he will continue to focus on that end of the business, but he added that the law would open up new avenues of

innovation by allowing small companies to develop cutting-edge automotive technologies by using these replica platforms. Smith, who sells several products that feature modern, original designs, said he thinks the restriction to classics is unfortunate, but he added that they attract people to car shows and other events, so the more of them out there, the better.

H.R. 2675 has been referred to the House Committee on Energy and Commerce, where it awaits further action. To qualify, companies would have to sell fewer than 5,000 cars worldwide each year.

## **JUNE 5 - ACCC URGENT LEGISLATIVE ALERT**

### **SB 8 Senator Hertzberg - Taxation .**

This California bill would state legislative findings regarding the Upward Mobility Act, key provisions of which would expand the application of the Sales and Use Tax law by imposing a tax on specified services, would enhance the state's business climate and would incentivize entrepreneurship and business.

*I read the above bill and am shocked that the legislature is actually trying to promote this bill as the "Upward Mobility Act". How is an additional sales and use tax on the citizens of California going cause any upward mobility. This bill is a scam on taxpayers and business.*

*The legislature wants to tax services, i.e. tax labor. For example, when you get your car fixed and the mechanic quotes \$400.00 labor you will pay probably 8% or an additional \$32.00 that you don't pay now. When you take your Hot Rod in to get body/ paint work and technician quotes a total of \$8,000.00 of which \$6,000.00 is labor you will pay an additional \$480.00.*

*This is scam and does not help the businesses who collect this money and pass it over to the state. I might add that California business collects this money for the state and receives no compensation for their efforts from the state.*

*I encourage all to contact your representative in both the assembly and the senate and voice your opposition to this taxation bill.*

### **SB 16 Senator Beall - Taxation.**

*I also read this bill again and found that unlike the advertisements and statements by the bill's author, Senator Beall a large portion of these revenues will go to the General Fund. This is what the legislature did over the last decade when they robbed funds from the highway accounts for their pet projects. This bill is not about fixing our crumbling highways and roads...It's all about Tax & Spend something that they are experts at!*

*I encourage all to contact your representative in both the assembly and the senate and voice your opposition to this taxation bill.*

The Senate Appropriations Committee says the effects of SB 16 (per the the Board of Equalization) Total revenues (excise and sales tax) from the gasoline and diesel tax rate increases would lead to revenue gains of \$1.048 billion in 2015-16 and \$1.863 billion in 2016-17 (General Fund and special funds).

The proposed \$100 fee on zero emission vehicles would generate \$10.8 million annually (special funds).

The proposed \$35 increase in the vehicle registration fee would generate \$1.085 billion annually (special funds).

Assuming no other changes beyond the increased VLF rate itself, the rate increase to 1.0% would generate \$1.216 billion annually when fully phased-in (General Fund).

## **CALIFORNIA BLACK PLATES ARE BACK!**

California license plates are finally back in black. The model is available through The California Legacy License Plate Program. The plates were originally issued from 1963-1969. The new black plates with yellow lettering are being made at Folsom prison.

The Department of Motor Vehicles announced Monday that it had started production on new California plates with black backgrounds and yellow lettering. The model, originally used from 1963-69, is available through the California Legacy License

Plate Program – a result of Los Angeles Assemblyman Mike Gatto's Assembly Bill 1658.



For the black plates to be issued, a total of 7,500 applications had to be turned in to the state agency. The DMV reached that number in June 2014. Gatto said his bill, introduced in 2012, was an attempt to preserve the state's "strong automotive culture ... . It started with the realization that there are an awful lot of people who like classic cars in this state. If you complete an old car restoration from the ground up, nothing is worse than being forced to stamp the current, bright-white license plate on it." Gatto is a car buff whose first car restoration was a 1971 Triumph Spitfire. He said that before his bill, the only option for car enthusiasts was to find old, authentic plates on eBay or at garage sales.

The problem, said DMV spokeswoman Jessica Gonzalez, is car owners must find a license plate that matches the car's model year, in compliance with the DMV's year-of-manufacture policy. "It's not easy and people end up paying an arm and a leg to get one," Gonzalez said. The California Prison Industry Authority discovered and restored the 1960s license plate molds at Folsom State Prison, where the custom classic plates will continue to be made.

Eric Menjivar, Gatto's communications director, described the reintroduction of the plates as a "nice gesture for old car lovers," trading "ugly white" for shiny black with yellow lettering.

California car owners can order the reproduced plates through the DMV for \$50 online or via mail. The price is the same for standard or personalized plate numbers. The DMV began processing 7,500 preordered plates June 17. Preorder customers can expect standard plate numbers to be complete within two to three weeks. Personalized plates – accounting for 55 percent of preorders – should be ready in August, Gonzalez said. Preordered plates will be available for pickup at local AAA or DMV locations.

## **COLLECTOR CAR APPRECIATION DAY JULY 10, 2015**

The U.S. Senate passed Senate Resolution 196 (S. Res. 196) at the request of the [SEMA Action Network \(SAN\)](#) designating July 10, 2015 as "[Collector Car Appreciation Day \(CCAD\)](#)." S. Res. 196 was sponsored by Congressional Automotive Performance and Motorsports Caucus Co-Chairs Senator Richard Burr (R-NC) and Senator Jon Tester (D-MT). The date marks the sixth commemoration in what has become an annual event to celebrate and raise awareness of the vital role automotive restoration and collection plays in American society.

A growing list of scheduled events, like car shows, cruise-ins and parades, will be held in support of this annual celebration. The SAN is maintaining the event list to commemorate the day at [semaSAN.com/CCAD](http://semaSAN.com/CCAD). Individuals, car clubs and business owners interested in publicizing events can submit the details [using this link](#). If you are unable to celebrate on July 10th, the SAN encourages events to be scheduled throughout the month of July to honor the classics of the past and the future.
