



the governor launched a new ballot measure committee. In publicly proclaiming the possibility of shifting from the Legislature to the ballot box, the Brown administration underscored its commitment to fortifying its climate change efforts, which the governor has placed at the center of his fourth and final term, despite pushback from some legislators.

As the legislative session accelerates into its final stretch, the fate of California’s cap-and-trade system has dominated talk at the Capitol.

Established under the auspices of a 2006 bill, the system requires businesses to buy permits for the climate-altering emissions they put into the air. But that authority could expire soon, since it is linked to a goal of reducing emissions to their 1990 levels by 2020.

That’s my best guess of what must have inspired the designer. After all the U. S. & Russia launched at least 7 tries to put a vehicle in orbit around the moon in 1958. All 7 failed for various reasons.

The Russian Luna 2 was the first rocket powered spacecraft to hit the moon, impacting the Moon on 14 September 1959.

CALIFORNIA CAP-AND-TRADE COULD GO TO BALLOT

The fight to extend California’s climate change program could mean putting the issue before voters, a top aide to Gov. Jerry Brown said on Thursday as

In a sign of uncertainty about the program’s future, the most recent auction generated far less revenue than projections, pulling in around \$10 million where previous auctions had reaped hundreds of millions. A bill before the Legislature would set a new 2030 target, shoring up cap-and-trade’s legal authority. But that legislation is in a tenuous position. It would need to clear the Assembly, where an earlier version of the bill died last year shortly after Republicans and moderate Democrats succeeded in diluting another Brown-championed climate bill.

Those obstacles aside, Brown aide Nancy McFadden said on Thursday the administration remains determined to fortify California’s climate programs. In a statement, McFadden rejected “the fallacy that a vote on any single measure in the next 27 days will make or break our climate agenda.” “We are going to extend our climate goals and cap-and-trade one way or another,” McFadden said.

“The Governor will continue working with the Legislature to get this done this year, next year or on the ballot in 2018.” McFadden’s statement accompanied the appearance of a new ballot measure committee affiliated with Brown, Californians for a Clean Environment.

Going through voters, rather than the Legislature, could also dispel some of the legal fog encircling cap-and-trade. An ongoing legal challenge charges that the program should have been passed with a two-thirds vote, rather than a simple majority. (They claim it’s a new tax)

Getting voter approval would remove the need to secure the program with a two-thirds vote, a high hurdle given the difficulty of putting together a simple majority.

With legislative prospects uncertain this year, the California Air Resources Board has also initiated an effort to establish new emissions goals. Shortly after McFadden’s statement, ARB chair Mary Nichols posted a message to Twitter saying it was “certain” California’s climate efforts would continue through 2030.

“Low carbon fuels, (zero-emission vehicles), renewable electricity, cap and trade are all in CA’s future,” Nichols wrote. Should the legislative effort resume next year, Democratic leadership could find themselves in a stronger position. In the Assembly, Democrats could expand their already-substantial margin by multiple seats.

Assembly Speaker Anthony Rendon, D-Paramount, has projected little urgency about making a deal this year, sources say, and earlier this week Senate President Pro Tem Kevin de León, D-Los Angeles, said he was “not going to negotiate a bad deal just to get it done.” “One way or the other, we’re going to get it done,” he said.

CALIFORNIA POLITICIANS LOOK TO PUSH THROUGH NEW GAS TAX

ACCC appeals for help to stop billions in new taxes!

California’s gas prices are currently the nation’s highest at nearly \$1 above the national average, according to data from GasBuddy. Unfortunately,

the Gas Tax 2016 by Senator Jim Beall (D – San Jose) would raise the price of gas even higher. The Gas Tax 2016, is a centerpiece of an “extraordinary session” called by Governor Jerry Brown for the specific purpose of raising taxes. The proposal is misguided and unnecessary because:

- Longtime gas tax proponent Jim Beall (D – San Jose) has joined with Assemblyman Jim Frazier to propose a 17 cent a gallon tax increase on gas combined with a 30 cent a gallon diesel tax increase. This proposal would amount to a \$7.4 billion a year tax increase.
- Governor Brown’s proposal would raise gas taxes by 6 cents a gallon, or a total of \$3.6 billion a year.
- The California Air Resources Board (CARB) recently imposed a new hidden gas tax This tax increase is estimated to have already added 10 – 15 cents a gallon to the price of gas.
- Even without counting CARB’s hidden gas tax, California gas taxes are ranked the second highest in the nation by the American Petroleum Institute.
- The gas tax increase proposals do nothing to address billions in gas tax money currently being diverted to other purposes other than transportation, totaling \$5 billion since 2010. The proposal also fails to address \$500 million in reported waste at CalTrans.

What can you do about it?

1. First, you can **find your representative and give them a call!**

CALIFORNIA AUTO MUSEUM SHOW & CRUISE SEPTEMBER 10th

NEW ROUTE! We are no longer leaving from Sacramento State, all vehicles (pre-registered and non-registered) will enter via El Camino. We highly suggest you pre-register for this event to limit long delays and lines for registration.

Schedule

4:00 pm– Registration opens and cruise begins!
Pre-Registered will check in on El Camino, there will be multiple lanes for Pre-Registered participants.

Non Registered participants will park in the Tognotti parking lot and register.

Food trucks, breweries, and bands will already be set up and rockin' and rollin' in their respective lots on Fulton Avenue while the cruise is going. One lane in each direction will be designated for cruisers to park during this time, and one lane in each direction will be open for cars to continue driving the loop. Cars will be cruising from 4 pm to 6 pm but can pull over at any time.

6:00 pm— All Cruisers will parallel park on the curb or in designated "Official Cruise" show lots. Spectators are then free to walk the street.

6:30 pm – Around this time, the California Automobile Museum and our sponsors will be judging the automobiles that are lined up on Fulton Ave. Cars that are in parking lots will not be judged.

8:00 pm – All trophies will have been given out.

8:30 pm-Street fair ends

9:00 pm-Streets re-open

Prices for this cruise are as follows
Cruise registration is non-refundable.

\$44 per car for museum members

\$49 per car for general public

General Information

Registration/check in and cruising is from 4 PM to 6 PM but cars do not need to cruise the entire time or even cruise at all. Registration will be open and cruisers are welcome to arrive anytime between 4 PM and 6 PM (but not any earlier). Once they check in, they can cruise until 6 PM or immediately find a place to park along the curb on Fulton. Cars can NOT arrive early, check in early, line up early, or park in any of the lots along Fulton between Marconi and Cottage before 4pm. There will be NO parking at Tognotti.

It is VERY important to pre-register- as we will have multiple lanes for check in and will make the Cruise run smoother.

Starting on August 1st, the registration price is \$44 for museum members and \$49 for general public.

There are no restrictions on year, make or model, anything that is eye-catching can be registered. However, it is up to the discretion of the Museum to approve or deny any vehicle.

CruiseFest is free for the general public; spectators may arrive as early as 4:00pm to watch the cars as they drive the cruise route.

Those wishing to register on the day of the event will pull into the Tognotti's parking lot on El Camino, where they will be directed to registration tables. From there, they can pull directly onto Fulton Avenue and begin cruising.

Where do spectators park?

There is plenty of space west of El Camino for people to park; additionally, there will be multiple lots (exact locations to be determined) where CruisFest spectators may park. There will be maps and signs on Fulton Avenue, and we will post a spectator parking map on calautomuseum.org/cruisefest2016 as soon as spectator parking locations are finalized.

Cruisers

Where do I go to start cruising?

Participants who have pre-registered will drive east on El Camino if on Bell. The street will be closed starting at Burgundy Way, and participants will be able to check in, get their shirts and goodie bags, and start cruising. There will be multiple lanes available for check in. Cars can NOT arrive early, check in early, line up early, or park in any of the lots along Fulton between Marconi and Cottage before 4 pm. There will be NO parking at Tognotti.

How long will the "entrance gate" be open for vehicles to enter the cruise route/loop?

Registration and entrance will be open from 4 pm to 6 pm. We will close down registrations and the "entrance gate" at 6 pm.

How are 500 cars going to be cruising in a loop during the 2 hours and how do they pull over and get back on?

The speed of the cruise is expected to be between 15-25 mph regulated by the CHP and the traffic lights. Traffic lights will remain operational to slow the cruise and allow pedestrians to cross traffic. These breaks in traffic also allow for drivers to pull into/out of the cruise loop safely. Cars must pull out of the cruise lane should their cars experience any problems including overheating. Tow trucks will be on site to clear the cruise lanes from 4-6pm and clear Fulton after 8:30 PM all at the car owners expense.

Is there anywhere to meet up before the cruise starts?

We recommend that cruisers, especially groups, meet at an off-site location west of Fulton (such as Arden Fair Mall, Howe Community Park, Howe Avenue Elementary School, or the 99 Cent Store on El Camino, for example) and plan on driving east on El Camino towards Watt at 4pm or any time up 6pm.

Please note: Only cars parked at the curb will be eligible for awards. If your car club or group is in a parking lot on Fulton Avenue, anyone wanting to be considered for an award will need to pull out onto the street. Judging will take place between 6:00 and 6:30.

Museum headquarters will be at Tognotti's (on the corner of El Camino Avenue and Fulton Avenue).
